Gift Ideas

Children in the age groups below are sometimes difficult to shop for and often overlooked by donors. Please use these helpful tips to help give a kid a Christmas.

Infants & Babies

- Baby monitors
- Bedding and blankets
- Onesies
- Diapers
- 0-24 months - clothes and winter outdoor attire, like snowsuits and hats
- Soothers and rattles
- Make sure the toy is age appropriate by the manufacturer's age rating (0 – 6 months) and (3 months +) are in highest demand
- Package should say 'Infant Friendly' or 'Baby's First,' 'Infantino,' etc.
- Developmental toys (Fisher Price, Baby Einstein, Playskool, Leap Frog Baby)
- No small parts

Children Ages 10 to 18 Years Old

- Gift cards in the \$30-\$40 value range would be best (Hudson's Bay, WalMart, Cineplex, Gap, Stitches, Chapters, Coles, Old Navy, Garage, Blue Notes, La Senza, etc.)
- Electronic games, age-appropriate board
- Sports equipment (soccer, basketball, football, hockey, skateboards, scooters, etc.)
- Roller blades, ice skates, snow boards
- Bicycle helmets
- Cosmetics (age appropriate: 16 – 18 years old)
- Personal care and grooming gift packs
- Hair products and accessories (curling irons, blow dryers, shavers, beard groomers, etc.)
- Diaries, journals
- Creative and craft supplies
- Purses, knapsacks/backpacks
